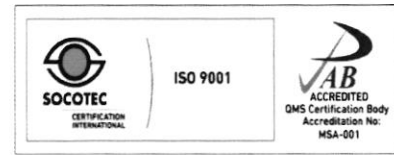

 - b.2. Contractor's bid in the Form of Bid, including its Technical and Financial Proposals, as calculated by the Procuring Entity and conformed to the Contractor through the NOA.
 - b.3. Bidding documents
 - b.4. Specifications
 - b.5. Special Conditions of Contract (SCC)
 - b.6. General Conditions of Contract (GCC)
 - b.7. Performance Security

3. In consideration of the payment to be made by the Department of Labor and Employment-Cordillera Administrative Region to Hexacom Enterprises as hereinafter mentioned, EFPIEL Enterprises hereby covenants with the Department of Labor and Employment-Cordillera Administrative Region to execute and complete the Contract and remedy any defects therein in conformity with the provisions of this CONTRACT AGREEMENT in all respects.
